## **First Things First!**

Call Emergency Services: 303.688.6447 before your moving truck arrives. Many streets within the Village will not accommodate moving vans in front of residences and may require the use of a smaller, shuttle truck. Prior approval must be obtained from ES for

ALL moving trucks coming into the Village and must be escorted by ES Officers. Contact ES or visit the CPV website for a Moving Authorization form.



## Visit the ES window at the CPHA office to complete the New Homeowner Information Packet and purchase an RFID tag(s) for gate entrance.

All residents (owners and tenants) are required to complete a set of new homeowner information forms. Please bring with you proof of ownership (title/deed) or proof of tenancy (copy of rental agreement). To receive an RFID tag you must bring each vehicle, a copy of the vehicle registration, proof of insurance, and driver's license. Log on to dwellingLIVE to set up your account, enter your contact information, and start entering your authorized visitors and guests. Schedule a New Homeowner Briefing. A representative from the Homes Association office will come to your home to review all of the services and amenities available to you within our community as well as discuss gate access and alarm monitoring. Contact the CPHA office at 303.814.1345 to schedule.

Visit the CPHA office to pick up your recycle bins. Two recycle bins are provided to each home free of charge. Visit the reception desk Monday - Friday, 8 am to 5 pm. Additional recycle bins can be purchased directly from Waste Management, or at Home Depot or Lowes.



**Sign up for the Village Weekly email newsletter**. Every Friday afternoon the CPHA sends out via email a weekly newsletter regarding upcoming events, important notifications and general information regarding your community. **Sign up for the CPV Homeowner's Directory.** The Homeowner's Directory is published once a year in the spring and is mailed directly to all residents in the Village.
